- **Patients Association report** The Patients Association has published its fourth annual report of 'Patient Stories', a series of case studies highlighting examples of poor care in the NHS. The report covers 13 accounts of poor care, written by the patients themselves or relatives of those who experienced it.

'These appalling and tragic cases serve to highlight the devastating consequences when poor practice is left unchallenged and unchanged. Behind each one are many more unheard voices.'

- **Change of name for the CHRE** From Saturday 1 December, the Council for Healthcare Regulatory Excellence (CHRE), which oversees bodies which regulate healthcare professionals, have changed its name to the Professional Standards Authority for Health and Social Care (PSA). The PSA will assess the performance, conduct audits and scrutinize the decisions of the healthcare regulators. - **Interprofessional working between the mental health services and the criminal justice system** In England and Wales there are unacceptably large numbers of people in prison or in contact with the criminal justice system who have mental health issues. Integrated and effective interagency collaboration is required between the criminal justice system and mental health services and interprofessional training is required to equip them with the skills and knowledge required to collaborate effectively. This report sets out the content of such interagency training, how it may be delivered and its potential benefits. - **Ward Rounds in Medicine, Principles for Best Practice'. A joint publication of the Royal College of Physicians and Royal College of Nursing: October 2012** Medical ward rounds require the concerted, coordinated collaboration of several healthcare professionals. However, the modern hospital environment has multiple challenges and barriers to effective team working that must first be negotiated. Work was jointly undertaken by the Royal College of Nursing (RCN) and the Royal College of Physicians (RCP) . A multiprofessional workshop was used to review research evidence of ward round practices, discuss examples of current best practice and identify principles of high quality care. The result is a series of recommendations for safe and effective delivery of ward rounds developed, which are set out in this guidance document.
