During the morning Hugh Barr and Marion Helme will present an update on their recent IPE Review with particular emphasis on research implications that have emerged from their findings. This will be of particular importance to CAIPE Corporate Members. The day will include a keynote presentation from Rebecca Baker and colleagues from the University of East Anglia entitled 'Enhancing student learning through service user involvement'. - **The GCC seeks a lay person for an External Examiner post.** The General Chiropractic Council (GCC) is looking to recruit a lay person (non – chiropractor) to act as an External Examiner who will be responsible for the overall quality assurance of the GCC's Test of Competence (TOC). The Test of Competence is the mechanism for the GCC to assess whether applicants to the register with qualifications from overseas are fit to practice in the UK. - **Mental health services: achieving better access by 2020, DH October 2014.** This paper is part of the government's mental health strategy. The report shows what action the government is taking to provide better access to care in mental health services within the next year, including national waiting time standards for the first time.
